- In addition to continuing **Medical Ministries** ([www.medicalministries.org](http://www.medicalministries.org)) – a division of HIM (our 501(c) 3, I stay committed to the **BUV Ministry** with a specific focus on **BUV Liberia**. - **BUVLiberia.org** – We still have a goal of developing a BUV Liberia manufacturing plant in Liberia. We have some new interest with some in key positions in the country with some hope of new funding sources. The BUV that we sent there already is being used as a display vehicle and on a farm as a working vehicle to illustrate the value for agricultural developments. Our mission for BUV Liberia is *“Transforming lives and communities in Liberia (West Africa) by training leaders in the marketplace and by developing sustainable community projects.”*
- With such slow developments in Africa, I have prayerfully launched a new focus and ministry called **Pastoral Counseling Institute (PCI)**. Specifically, after some time to evaluate how it has been a challenge to keep Medical Ministries moving forward, I was reminded that my main interest is related to my second Masters degree which is in Counseling. After reading Strategic Pastoral Counseling, a book in its second edition by David Benner and seeing the stats, it seemed possible to launch the **Pastoral Counseling Institute (PCI)** with a website at [www.PCImentors.com](http://www.PCImentors.com). The mission is to offer *training for strategic pastoral counseling for pastors and for those they mentor*. I can do this by Skype and conference calls with training and mentoring sessions with pastors who unfortunately do not get trained well for the amount of counseling required by parishioners weekly. Statistically, 87% admit a lack of necessary training. Those I train can easily mentor others on their staff with this same information. Thus, this is why I chose to use the PCImentors.com website. - **Truckers4Hire** – I continue to work this company but in a different role. I help to develop [www.truckers4hire.com](http://www.truckers4hire.com).
- **Stream / Medicus / Postmates** – I still hope that our Stream Mobile services (AT&T and Sprint services) will be added to our **Power Up Program (PUP)** fundraiser soon. Postmates is similar to Uber except I deliver meals. What is neat is that this daily courier work gives me a chance to recruit some candidates to consider Stream and Medicus as an extra source of income.
