This short 12 chapter book outlines eleven essentials of what a disciple of Jesus Christ is and how each disciple should become a disciple-making disciple. These study guides offer an outline of the book with some questions to be used in reviewing and discussing the content. Each student will need to obtain and read the book as well. After the initial chapters titled: What is a Disciple? & The Disciple is a Learner; the author reviews the Lordship of Jesus Christ which is the umbrella for the remaining nine essentials or characteristics of a disciple.

- I. INTRODUCTION EOD #10: A disciple gives regularly and honors God with his or her finances.
 - A. Summary (from Chapter 1):

The disciple must be giving to the Lord's work. That is – honoring God with our money. (In my opinion, some may give more of their time, which is money, especially if they cannot generate income from their time). In the Old Testament, God required a tithe (10%). It can be assumed that if we do not honor God with our money (or time vs. money), we may be letting Satan, the enemy, use it for his evil purposes. The Bible speaks of contributing to the needs of your instructor who is helping you grow spiritually (Galatians 6:6).

 - 1. Start with 11% not just 10%. That is, don't be legalistic. Give what you are able. Just be generous.
 - 2. Give to the Lord first that is, His Church. That is churches that preach and teach the Gospel.
 - 3. Give
 - 4. Make extra gifts. Support your local church or churches. Support organizations, missionaries, causes, etc. Why should we support first your local church?
 - 5. Honor your pledges. What is suggested if the level of your giving falls and you are unable to make your commitments? Who should you notify and when? Why is this important? (Think of budgeted expenses).
